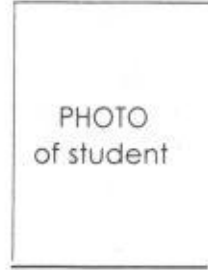

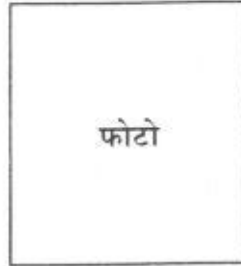

1. This agreement is made on thisday of2017 between(herein after called as guarantor which expression shall, unless excluded by the context of the meaning thereof, deemed to include his heirs, executors, administrators and legal representative), as one part and Navodaya Vidyalaya Samiti New Delhi (herein after called the Samiti which expression shall unless excluded by the context or the meaning thereof, be deemed to include Principal Jawahar Navodaya Vidyalaya on the other part.
2. Whereas Master.....(Admission No.....) Son/Daughter of Sh.(herein after called the student)is Ward of the guarantor and has at the request of the guarantor been selected through test for admission to Jawahar Navodaya Vidyalaya state interalia ,on the terms and conditions herein after appearing ,for the purpose of receiving educations.
3. Now it is hereby agreed by & between both the parties hereto as follows :-
 - (A) That in consideration of the student being admitted by the Samiti Jawahar Navodaya Vidyalaya..... state..... For the purpose of aforesaid education at the request of the guarantor, he the guarantor covenants with the Samiti that the student will attend the Jawahar Navodaya Vidyalaya State Regularly and will observe and comply all the rules and regulation thereof for the prescribed period i.e. up to XII studies in said Vidyalaya
 - (B) That it after admission any of the following viz. proof of residence certificate, age certificate, school leaving certificate & all the informations supplied by the guarantor is found to be false in any way or not in the order the student will be expelled from the school with immediate effect &the guarantor shall forthwith pay to the Samiti the total expenditure incurred by the Samiti on the student for the period the student was at the said Vidyalaya
 - (C) That if the guarantor withdraws his ward from the Said Vidyalaya before the completion of his studies on grounds other than genuine medical ground due to which the student is not able to pursue hi studies in the Vidyalaya which shall be certified by the chief medical office /civil surgeon of govt. hospital .the guarantor shall forthwith pay to the Samiti the total expenditure incurred by the Samiti on the student for the period the student was at the said Vidhyalaya.
 - (D) That the samiti will not be fliable to any damages ,charges on account of injuries ,fatal or otherwise which may be sustained by the student at any time during his stay in said school ,while taking part in sports NCC ,Co curricular activities or any other form of activities of the Vidyalaya with in or outside the vidyalaya premises including while on migration.
(as per policy of the Samiti), educational torus, excursions, tracks, scouts and guide activities undertaken through any mode of transport/travel. All expenses that may be incurred in treatment in such injuries or illness will be borne by the parents/ guardians as provided in the rules of the said school.
 - (E) That the samiti can in the larger interest of the school have the student removed from the school if in the samiti's opinion, the student has fail to accept the discipline of the school/ indulged in abusing or man handling in any of student or staff members /indulged in teasing to junior students in any form/ abusive towards his classmates and housemates/ showing disrespect towards girls students or ladies/ indulged in activities of grouping and instigating students against any other student or against any particular class of students or teachers or any staff members or school administration, and his continued presence in the school is detrimental to the interest of the other students in such a case the guarantor shall pay to the samiti, on the demand the expenditure incurred by the samiti on the said student for the period of student was at the said school.
 - (F) That the samiti can in the larger interest of the school have the student removed from the school if the student face to come upto the academic slandered of his class and in such a case the guarantor shall pay to the samiti, on demand the expenditure incurred by the samiti on the said student for the period of the student was at the said school.
 - (G) That as the samiti which to promote the national integration and to provide an opportunity to the student of the Vidyalaya a to understand the people and culture of other part of the country have a scheme to migrate the students of class IX from Hindi to non Hindi state and vice versa the guarantor shall has no objection sending to the student who is his ward to the clubbing vidyalaya on migration as decided by the navodaya vidyalaya samiti. If

guarantor shows the reluctance his ward who is the students of this vidyalaya for any reason other than genuine medical ground due to which the student is not able to proceed on migration to the clubbing vidyalaya, which shall be certified by the chief medical officer/civil surgeon of the govt. hospital, the samiti can in the larger interest of the school have to remove the student and the guarantor shall forthwith pay to the samiti the total expenditure included by the samiti on the student for the period the student was at the said vidyalaya.

- (H) That if the student causes any damage of the property of the school willfully or accidentally, wholly or partially, individually or in a group, the fine as imposed by the samiti on individual or in group the guarantor shall forthwith pay to the samiti amount as fixed and in case of repetition of such things the act will be treated as indiscipline and the samiti can in the larger interest of the school have the student removed from the school, the guarantor shall pay to the samiti on demand the expenditure incurred by the samiti on the said student for the period of the student was at the said school.
- (I) I shall drop to my ward in vidyalaya premises after leave / vacation personally and collect him/her for leave/ vacations and shall be personally responsible for any untoward incident on the way. Further I shall report in the vidyalaya on call from vidyalaya authorities on date and time as fixed by them. I shall peruse my ward to accept and comply the rules and regulations of the vidyalaya/ NVS.

In the event of any question, dispute or difference arising under this agreement (except as to matters of decision of which is especially provided for in this agreement) the same shall be referred to the sole arbitration of an officer appointed by the secretary ministry of law, govt. of India New Delhi. It will be no objection that arbitrator is a govt. servant and that he had to deal with matters to which the contract relates. The award of the arbitrator shall be final and binding on the parties to this contract. In the event of the arbitrator retiring or being unable to act for any reason, it shall be lawful for the secretary to nominate another arbitrator. The arbitrator from time to time, with the consent of the parties enlarge the time for making the award.
